

Here is the list of Federal Grants received on or after October 1, 2012, by the Public Utility Commission of Oregon:

- US Dept. of Transportation – Pipeline and Hazardous Materials Safety Administration (PHMSA) Grant - Federal Funding on an annual basis for State of Oregon to carry out the Pipeline Safety Program. In the 2015 Payment Agreement, PHMSA will reimburse PUC based on available funding the lesser of \$651,386 or a percentage of PUCs actual approved cost.
- US Dept. of Transportation - Pipeline and Hazardous Materials Safety Administration (PHMSA) “One Call Grant”– Federal Funding on an annual basis for assisting the State with improving its One Call Notification program to support state excavation damage prevention efforts. For 2015 Agreement, \$20,000 is allocated for Development and/or conduct training for locators. We pass all the amount of this grant to Oregon Utility Notification Center (Oregon 811).
- US Dept. of Commerce - National Telecommunications and Information Administration (NTIA)-ARRA Grant- State Broadband Data and Development Grant- \$ 2,881,866 remaining balance of the ARRA grant received after Oct 1, 2012. This ARRA-Broadband started December 2009 and completed/closed on March 2015, with cumulative spending of \$5,176,281.83 through March 2015.
- US Dept. of Energy – National Energy Technology Laboratory (NETL) - ARRA Grant- State Electricity Regulators Assistance Grant- \$75,445 remaining balance of the ARRA grant received after Oct 1, 2012. This ARRA – Electric grant started January 2010 and completed/closed on June 30, 2013, with cumulative spending of \$844,680 through June 30, 2013.
