

- 4 Enclosure 1 – Memorandum, Item 1, requests disclosure of contract or subcontract "...received during the current fiscal year or either of the two previous fiscal years..." However, Enclosure 3 – "Truth in Testimony" form, Item 5, 6 & 9, indicate "...on or after October 1, 2013..." Therefore, FTI has taken the most cautious approach to presenting information from October 1, 2013 to present to the best of our knowledge.
- 5 FTI's commercial IT subsidiary (FTI Services) awards are not included since there is no Government related activities.
